I. INCLUDE TWO OR MORE OF THE FOLLOWING DOCUMENTS SHOWING THE PRESENCE OF YOUR ANCESTOR IN THE ROGUE VALLEY BY 1900 OR EARLIER. DO NOT SEND ORIGINAL DOCUMENTS, THEY CANNOT BE RETURNED!

1. A Federal Census of Oregon showing your ancestor.
2. School records, school census, report card.
3. Donation Land Claim or land ownership, plat maps, deeds.
4. Declaration of Intent for Citizenship.
5. Church membership, baptism or confirmation.
6. Marriage license certificate showing an Oregon location.
7. Bible record showing Oregon birth, marriage or death.
8. Newspaper obituary or article showing Oregon residence.
9. Will, estate or probate records.
10. Oregon State or county history or biographies, give source.
11. Picture of Inscription on gravestone, state and county in which located.
12. Other proofs, letters, bible records, diary entries.

II. INCLUDE A DESCENDANCY CHART SHOWING YOUR RELATIONSHIP TO THE PIONEER/EARLY SETTLER.
